Please also note that you waive any right to royalties or other compensation arising from or related to the use of the images.

With regard to GDPR we must ask parents/carers to give consent, and we ask that you engage your child in the discussion to seek their opinion. Individuals must now specifically opt-in to allow images to be used for purposes such as websites, internally within itsu, social media, newsletters or press releases. A general opt-in would not be valid, instead a detailed account of all of the purposes the images could be used for must be presented, in as clear and transparent format as possible. We must ask you to choose Yes or No for every option and, should you choose No for all options we will still require you to return the form to your child's class teacher/school.

Consent is defined by the GDPR as "any freely given, specific, informed and unambiguous indication of the data subject's wishes by which he or she, by a statement or by a clear affirmative action, signifies agreement to the processing of personal data relating to him or her".

We do wish to remind parents/carers that once consent has been given or refused, this can be amended at any time in writing. We will then take all reasonable efforts to enact this request as quickly as possible.
